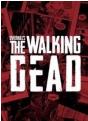

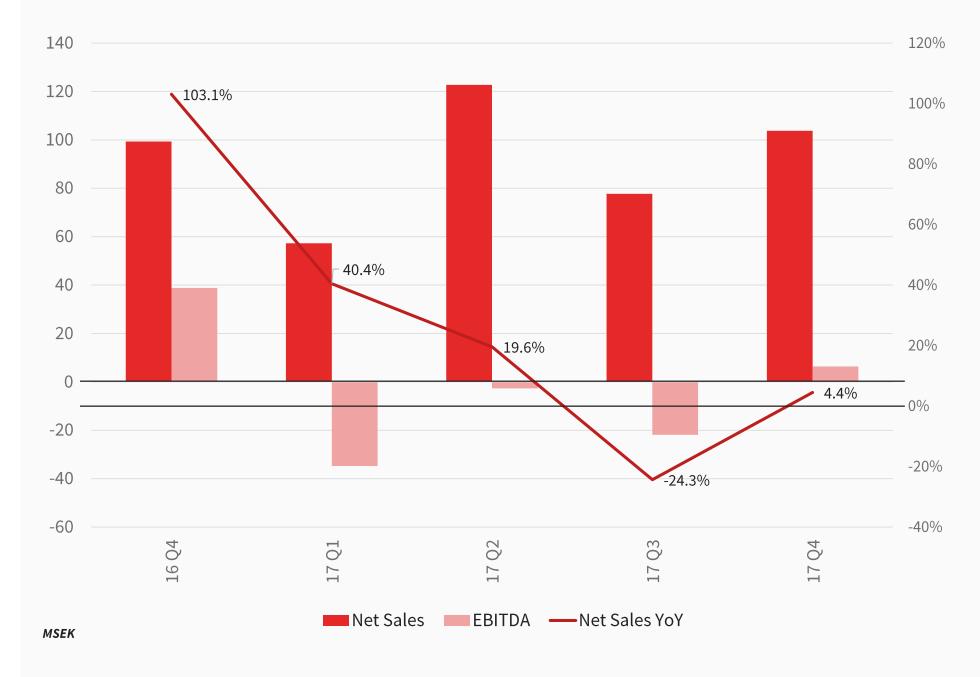

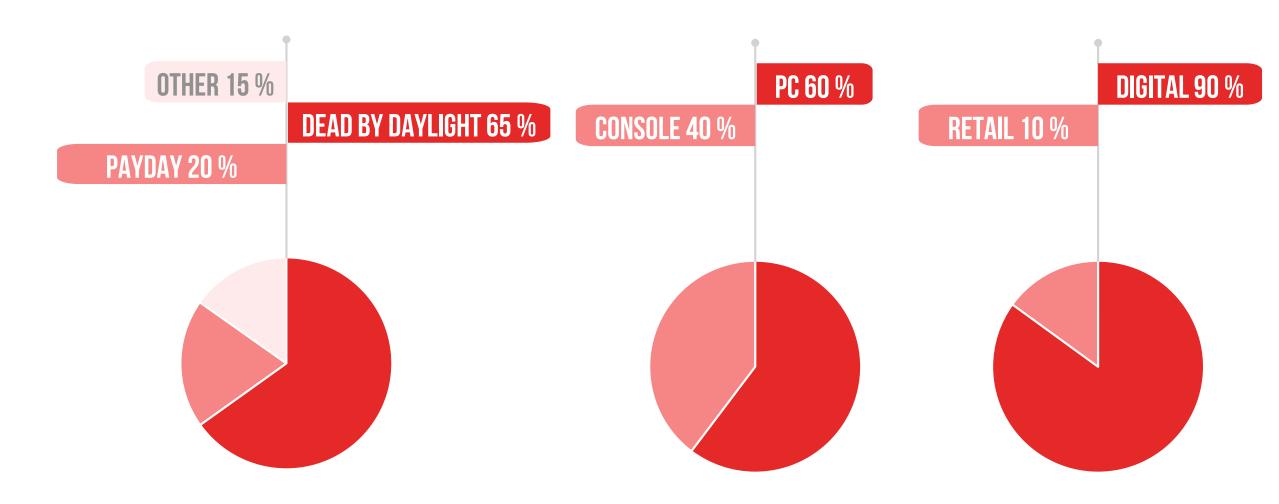
BEST FOURTH QUARTER TO DATE IN TERMS OF REVENUES

FOURTH QUARTER 2017

- Net sales increased by 4.4 percent to SEK 103.8 million.
- Dead by Daylight generated revenues of SEK 67.6 million –
 13 million higher than Q4 2016 even though it's one year older.
- Positive EBITDA of SEK 6.4 million.
- Impairment loss on RAID of SEK 20.2 million.
- Loss after tax SEK 63.0 million

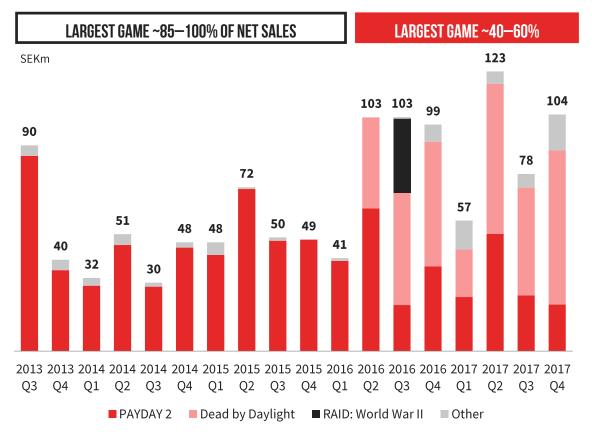


STRONG NET SALES DEVELOPMENT

NET SALES DEVELOPMENT, 2013 Q1-2017 Q4

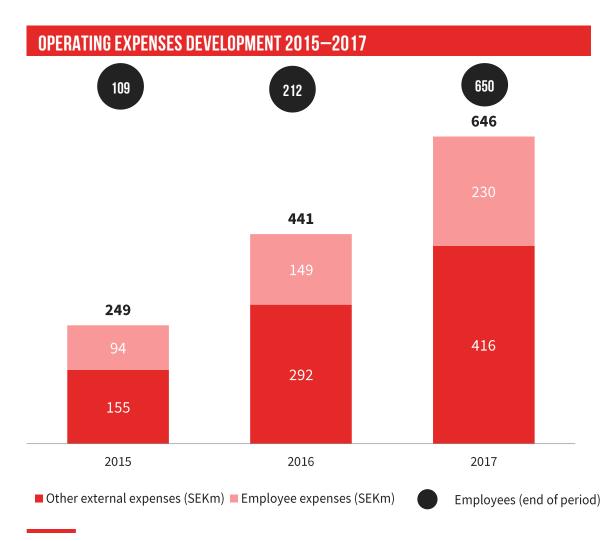


NET SALES BY TITLE PER QUARTER, 2013 Q3-2017 Q413

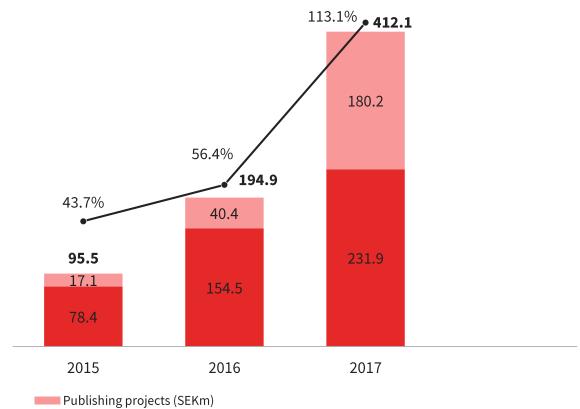

COMMENTS

- Due to accounting standards there will be substantial movement within the financial net.
- Net impact from financial income and financial expenses amount to SEK 24,8 million.
- Largest item being revaluation of earn outs (SEK -15.8 million) of which SEK -8.1 million in exchange losses.
- The majority of net financial income and expense for both the quarter and the period had no impact on cash flow.

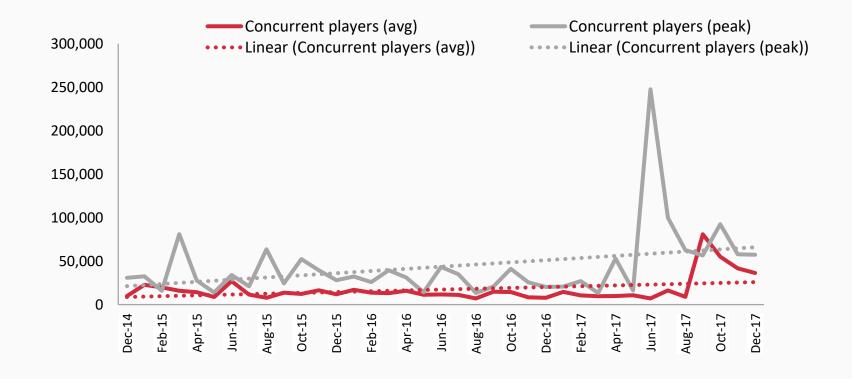

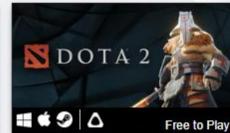

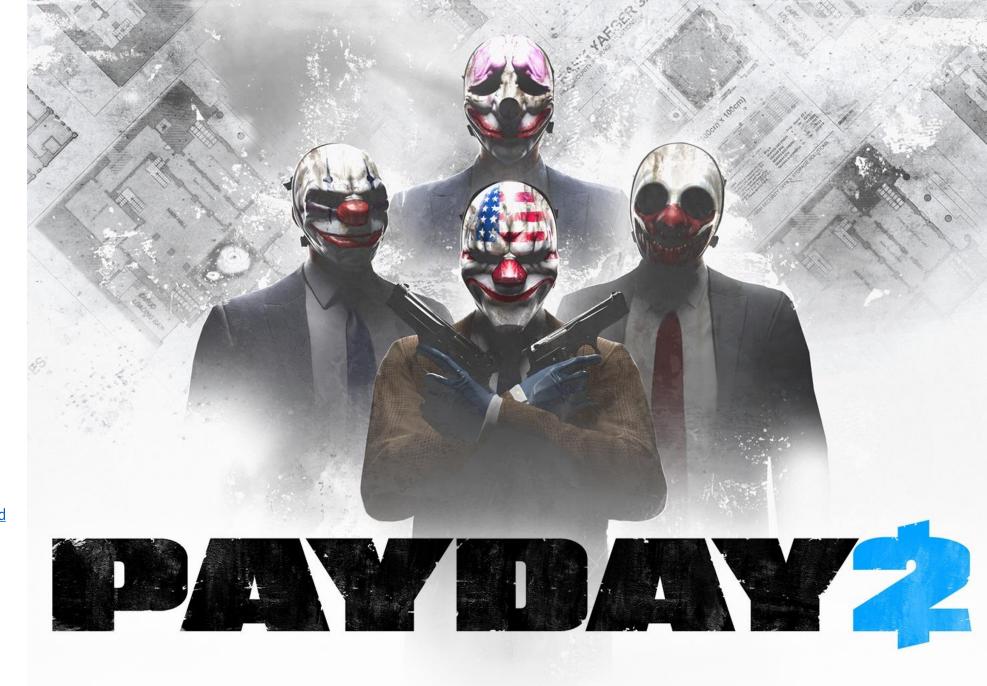
